



## DOG LICENSE NOTICE TOWN OF GRAND ISLAND

### DID YOU KNOW?

Under Article II of the Grand Island Town Code, Section 101-16, and under the New York State Agriculture and Markets Law, ALL dogs four months of age or older MUST be licensed in the municipality in which they are harbored.

If your dog(s) has a Grand Island issued license that is up-to-date, *NO action is needed*. However, **if you harbor any dog(s) that are currently unlicensed, or whose license is expired, please fill out the form on the reverse side of this Notice and provide the necessary paperwork to license the dog(s) to the Grand Island Town Clerk.** The Town Clerk's Office is open Monday-Friday from 8:30 a.m. to 5:00 p.m.

You will need the following paperwork to obtain a license:

- \* Proof of current rabies vaccination – signed certificate from veterinarian
- \* Proof of being spayed/neutered if applicable (an affidavit is accepted in lieu of a certificate – available in the A-Z Guide on the Town's website: [www.grandislandny.us](http://www.grandislandny.us))

The cost for a license is as follows:

\$8.00            If the dog is spayed/neutered  
\$16.00          If the dog is not spayed/neutered

Seniors over 65 qualify for a reduced license fee (please call for info)

You may also mail in the form on the reverse side along with your required payment and documents, or use the drop box located outside Town Hall. Please include a self-addressed stamped envelope as your paperwork, tags, and license will be processed and returned to you.
